# Update on the work in your building



As we announced last May, work is starting in your building.

The contractor is finishing their preparations. We have implemented measures to limit the effects on you and ensure everyone's safety.

## Availability in the common room

- You have concerns about what is coming in the future for your building.





#### Loaning air conditioners

Residents could request a portable air conditioner (standalone unit on wheels). Air conditioner installation is ending for apartments.

#### We are currently adjusting the electrical system to meet demand:

- 1 An additional electrical box will be installed for all residents who have requested an air conditioner.
- 2 A metal tube will be added to protect the wires. It can be painted white to make it less visible.

Please call your liaison officer if you would like to:

- Have the metal tube painted;
- Tell us about other concerns;
- Have an air conditioner while the work is being done;

# **Next steps in the construction process**

The contractor has finished installing their scaffolding.

 For your safety, they are in the process of restricting access to balconies affected by their work.

They are **blocking off** your **patio door** during work on your facade.

The contractor will **install a system so you can open your door** to let air into your apartment. You will be able to open your door 4 inches. You can still use your screen door.

- The contractor will then remove the railings from the balconies.
- Then they will start demolishing the brick.

## Schedule

Mid-May 2023 to the end of 2024

Work on the facades overlooking the **alley and Lajeunesse Street:** Mid-May 2023 to early 2024

Work on the facades overlooking **Jarry Street and Berri Street:** Early 2024 to late 2024



Monday to Friday, between 7:00 a.m. and 5:00 p.m.

Appointments inside the apartments: Starting at 8:00 a.m.

At times, work could extend into the evening or weekend. Construction hours will be respected according to your borough's rules.

## **Inconveniences** caused by the work

- There will be noise and dust.
  - Do not forget to keep your **doors and windows shut during construction hours.** This will limit the amount of dust that gets inside your apartment.
- There will be machinery, scaffolding, and bucket trucks outside your apartment.
- During the work on the facade:
  - Workers will be moving in front of the windows on scaffolding or using a bucket truck.
  - You will not have access to your balcony.
  - For your safety, **your patio doors will be blocked off.** However, a system will be put in place that will allow you to open them to let air into your apartment.
- For summer 2023:
  - You will have access to the terrace next to the common room.
