Participate in OMHM elections

You are invited to vote on April 20 to elect two tenant members to sit on the Board of Directors of the Office municipal d'habitation de Montréal (OMHM), along with representatives and alternates for the Selection Committee and the Committee on Housing Transfers due to Biopsychosocial Reasons.



Who can apply?

Tenants 18 years of age and older who are named on the lease and have obtained the support of their Tenant Association Committee or of 10 tenants of their building.

Tenants of low-rent housing, residents of the ENHARMONIE network, Benny Farm buildings and other affordable housing complexes may apply to sit on the Board of Directors.

The remaining positions on the Selection Committee and the Committee on Housing Transfers due to Biopsychosocial Reasons are reserved for tenants in low-rent housing.

Selection Committee A rewarding experience with a compassionate team

Tina-Lili Gagné

For the past three years, Tina-Lili Gagné has been a member of the Selection Committee of the Office municipal d'habitation de Montréal (OMHM). This committee determines who is eligible for low-rent housing. Ms. Gagné has learned a great deal about the OMHM's methods during the Committee's discussions. She has observed that each file is reviewed according to strict criteria and that the Committee takes the time to ask the right questions. "I'm here to give the tenant's perspective. The other members are very open. They listen and respect my opinion."

Ms. Gagné sometimes plays the devil's advocate because it is easy to feel moved in some cases. "Empathy is important, but you have to be able to put things in perspective. We have to pay attention to telling details that distinguish a risk of domestic violence from a desire for emancipation, for example." Tina-Lili Gagné relies on her own life experience while striving to remain objective and fair. She is mindful that her work can change the course of someone's life. It must therefore be done well to avoid abuse and ensure that apartments go to those who need them the most.

The CCR HLM is to be renewed

At the end of March 2022, the seven new sector committees for low-rent housing will meet for the first time. There will be only one item on the agenda: electing representatives from each sector to renew the Comité consultatif des résidants (CCR or Advisory Committee of Tenants). All lowrent housing tenant associations will be contacted to take part. Stay tuned to participate in these elections. too!

Board of Directors Dare to speak and know how to listen: essential qualities

Raymond Saulnier, resident of Habitations Des Fleurs, and Suzanne Payant, resident of Habitations De l'Érablière, are both members of the Board of Directors of the Office municipal d'habitation de Montréal (OMHM). They want to share their experiences to raise awareness of the qualities needed to be a Board member.

Raymond Saulnier has served on the Board for the past year. He was fortunate to receive valuable advice from Sylvain Labrecque before his death. "It's important that tenants are represented by people with experience and knowledge. Sylvain was a mentor to me. He shared his knowledge with me so that we didn't lose the advances that have been made for tenants." In addition to experience, Raymond Saulnier says it's important to remember your worth and not be afraid to speak up. The various perspectives of Board members have helped him understand the processes and constraints that management faces. "There's also a lot of reading to do. Every month, we have to prepare for and take part in meetings with the two Comités consultatifs des résidants (CCR or Advisory Committee of Tenants for lowrent housing and ENHARMONIE residences). You have to be curious and not afraid to learn," he says.

"When you're a member of the Board, you represent all tenants. You need to be a good listener, have good analytical skills and be able to communicate tenants' needs well," says Suzanne Payant, who replaced Sylvain Labrecque in October 2021. According to her, Board members need to be great listeners and be open-minded. For her, it's important to listen to everyone and be able to put yourself in the other person's shoes so you can properly convey their concerns. "You can always complain, but complaining and criticizing doesn't get you anywhere. The point of getting involved on the Board is that you want to change things. To do that, you have to be motivated to find solutions, and that requires openness and analytical skills," she says.

There's no doubt that many tenants in the various housing programs managed by the OMHM have these skills. Good luck to all those who submit their application to contribute to the Board's work!

Committee on Housing Transfers due to Biopsychosocial Reasons Making your time count

Giovanni Iuliani has just completed his second term on the Committee on Housing Transfers due to Biopsychosocial Reasons. He finds it interesting to participate in this Committee's discussions alongside knowledgeable social workers who treat him like a colleague. "You hear all sorts of unbelievable stories, sometimes lies and sometimes exaggerations. You have to be able to figure things out, analyze the files—which are anonymous—and think about the wellbeing of people at risk, including children."

This historian and circus artist likes getting involved because he thinks it's vital to be useful and active, not to sit around doing nothing. "I put many hours into the Committee. At 82, my hours are numbered, so what I do with them should mean something. Every minute counts!" That's why he's quick to ask questions if information is missing from a file or something is unclear. "I'm there to spark discussion." He says that sometimes he does not approve a transfer because the situation seems unclear or the justification is unconvincing. In these cases, the file is put on hold so the Committee can get more information before making a decision.

7 positions to be filled





On the **Board of Directors: 2** tenant members.

One tenant will be elected from seniors' housing and the other will come from housing for families and people living alone. *All eligible OMHM tenants can apply for one of these two positions*.

The Board of Directors of the OMHM has nine members: five are appointed by the Montréal Agglomeration Council, two are appointed by the Québec government and two are elected by tenants.

Together, they establish the guidelines, objectives and priorities of the OMHM. The Board members are also the guardians of the organization's ethics and budgets. They hold approximately eight meetings per year.

The tenant members of the Board of Directors also become members of the two CCR (CCR HLM and CCR ENHARMONIE), which hold approximately eight meetings per year.



On the **Selection Committee: 2** tenant representatives and **1** alternate.

Only low-rent housing tenants may apply for these positions.

This committee makes decisions regarding the eligibility and priority order of low-rent housing applicants.



On the Committee on Housing Transfers due to Biopsychosocial Reasons:

1 tenant representative and **1** alternate.

Only low-rent housing tenants may apply for these positions.

This committee has the mandate to analyze and then accept or refuse requests for housing transfers for reasons related to tenant health or safety.
