



Elections: Will you be the next OMHM Board member?



The Office municipal d'habitation de Montréal (OMHM) must hold elections to fill a position on the Board of Directors. This position is vacant because Raymond Saulnier resigned.

For the next two years, you could play an important role. Are you a committed tenant? Do you enjoy working in a team? Do you want to make decisions that help fulfill the OMHM's mission? Apply now! You have until March 13, 2023.

Who can apply?

Tenants of low-rent housing for seniors, ENHARMONIE network residents and Benny Farm tenants may apply.

To apply, tenants must be 18 years of age or older, be named on the lease, and have the support of their tenant association committee or of ten tenants in their building.

What do Board members do?

Board members help oversee and monitor the OMHM's affairs. They do this by working as a team to make decisions about the organization's objectives and priorities. Board members must monitor the OMHM's budgets. They meet about 8 times a year.

Two tenant members are elected to sit on the **Board of Directors**: one comes from low-rent housing for seniors while the other comes from low-rent housing for families and people living alone (Suzanne Payant was elected in April 2022).

The OMHM's Board of Directors has **9 members**: 5 are appointed by the Montréal agglomeration council, 2 are appointed by the Quebec government and **2 are elected by tenants**.

Tenant members of the Board of Directors also become members of the Comité consultatif des résidents (CCR or Advisory Committee of Residents) for low-rent housing and ENHARMONIE residences. Each committee meets about 8 times a year.
